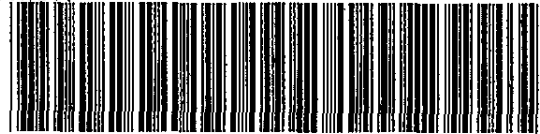



The undersigned submits these Articles of Organization pursuant to *F.S. §608.407*.

ARTICLE I

The name of the Limited Liability Company (the Company) is:

FAITH IN CHRIST ANGLICAN CHURCH, LLC

ARTICLE II

ARTICLE V

The Company is to be a manager/managed company. The initial managers shall consist of three (3) persons and they shall serve until the first annual meeting of the Member(s) or at any duly scheduled and announced meeting of the Board of Directors and/or the vestry of the Member and the subsequent appointment of the successors managers by the Member. The initial managers' names and addresses are:

Managers shall be appointed to serve for two (2) year terms. However, the length of terms and the number of managers hereafter shall be determined by the Company's operating agreement and/or its By-Laws.

ARTICLE VI

The Company shall have one (1) member, namely:

FAITH IN CHRIST ANGLICAN CHURCH, INC.
a Florida not-for-profit corporation

ARTICLE VII

Purpose

The purpose of this company shall be:

1. The power to adopt, alter, amend or repeal the regulations of the Company is vested entirely in the Member.

2. To encourage worship according to the faith statements and tenants of the scriptures, the Old and New Testaments as the revealed will of God, as the all sufficient rule of faith, doctrine and practice, containing all things necessary for salvation and as interpreted through the witness of the 1928 Book of Common Prayer, the historic creeds of the undivided Catholic Church (i.e., the Apostles', Nicene and Athanasian creeds) and such other statement as the Affirmation of St. Louis. To follow the constitution and canons for the government of the Dieseces and National Church of the United Episcopal Church of North America as it provides a faithful witness to scripture, and also directs and governs the church in matters which the scriptures do fully treat or are silent of, but are necessary to the health of the church.

3. To encourage stewardship through the receiving of bequests, but not limited to bequests in wills or living trusts, assignment of life insurance, assignment of certificates of deposits, charitable remainder trusts, and the transfer of property such as cash, stocks, bonds and real estate.

4. To accrue and preserve such gifts so that the principal is maintained and the income thereof is distributed to enhance the ministries of the Member, apart from general operating expenses.

5. The Company is organized exclusively for charitable and/or educational purposes consistent with the Member's §501(c)(3) status under the Internal Revenue Code.

ARTICLE VIII

The Company is intended to be treated as a branch of its Member for federal and state income tax purposes, except as otherwise required under applicable law. The Company shall take such actions including the making of available tax elections, as are reasonably necessary to insure the Company will be so classified.

The Company is established for the exclusive benefit of the Company, its Member and its successors and assigns. This Company is expressly not intended for the benefit of any creditor of the Company or any other person. Except and only to the extent provided by applicable statute, no such creditor or third party shall have any rights under or against this Company or any agreement between the Company and any Member with respect to any contribution or otherwise.

ARTICLE IX

In the event of the dissolution of this Company, the residual assets of the organization shall be turned over to Faith In Christ Anglican Church, Inc. or its successors in interest. In the event Faith In Christ Anglican Church, Inc. or its successor is no longer in existence, then to such other organization or organizations organized and operated exclusively for religious purposes and specifically of the Anglican faith, or to such organization or organizations organized and operated exclusively for charitable,

educational, religious or scientific purposes as shall qualify as an exempt corporation or organization under §510(c)(3) and §170(c)(3) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, of the federal, state or local government for exclusive public purposes.
