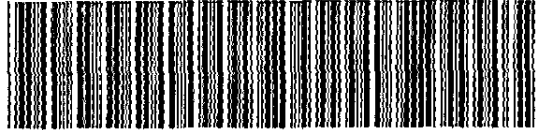



**ARTICLES OF ORGANIZATION
OF
SG STEEL SERVICES, L.L.C.**

The undersigned, for the purpose of forming a Limited Liability Company, under the Florida Limited Liability Company, Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I-NAME

The name of the Limited Liability Company shall be SG STEEL SERVICES, L.L.C., ("Company"). The principal place of business of the company in Florida shall be 850 NW 61st Street Fort Lauderdale, Florida 33309.

ARTICLE II-DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these Articles of Organization.

ARTICLE III-PURPOSES OF POWERS

The general purpose for which this company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The company shall have all the powers granted to a limited liability company under the laws of the State of Florida.


ARTICLE VI-TERMINATION OF EXISTENCE


