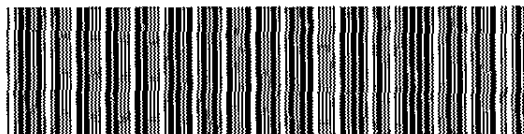


5. All remaining property and assets of the Company have been distributed to its members in accordance with their respective rights and interests.
