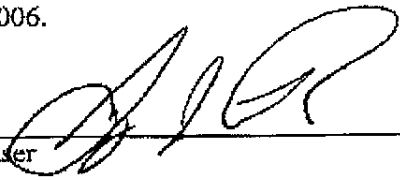
#### ARTICLE 6

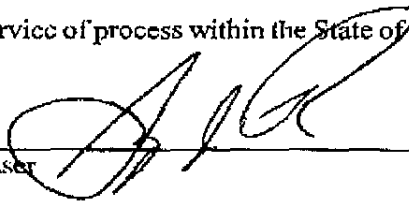

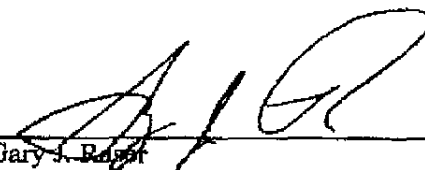
