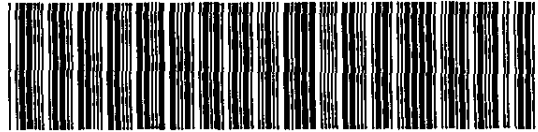

**ARTICLES OF ORGANIZATION  
OF  
K & L'S HOME IMPROVEMENT, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be **K & L'S HOME IMPROVEMENT, LLC**. ("Company").

**ARTICLE II -- ADDRESS**

The street address of the principal office of the company shall be 457 River Road, Lot #2, Oak Hill, FL 32759 and the mailing address is P. O. Box 665, Oak Hill, FL 32759.

**ARTICLE III -- DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual.

**ARTICLE IV -- REGISTERED OFFICE AND AGENT**


