ARTICLES OF ORGANIZATION

OF

J-PEC, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, <u>Florida Statutes</u>, Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be: J-PEC, LLC.

ARTICLE II - ADDRESS

The street address of the principal office and mailing address of this Company is 1340 Scottsland Drive, Lakeland, FL 33813.

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is dissolved earlier, as provided in these Articles of Organization or in the Operating Agreement.

ARTICLE IV - REGISTERED OFFICE AND AGENT

and accept the obligations of my position as Registered Agent, as provided for in Chapter 608, Florida Statutes.




