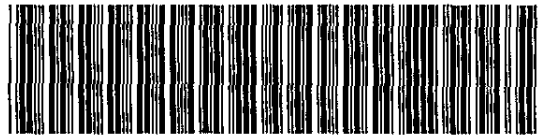

**ARTICLES OF ORGANIZATION
OF**

WERLEY & ARROYO - FLOORING SPECIALISTS, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE 1. NAME

The name of the limited liability company shall be WERLEY & ARROYO - FLOORING SPECIALISTS, L.L.C. ("company").

ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the company shall be 3649 Edgewood Avenue, Fort Myers, Florida 33916.

ARTICLE III. DURATION

The company shall commence its existence on the date these articles of organization filed by the Florida Department of State. The company's existence shall be perpetual, unless company is earlier dissolved as provided in these articles of organization.

ARTICLE IV. REGISTERED OFFICE AND AGENT

ARTICLE IX – MANAGEMENT




