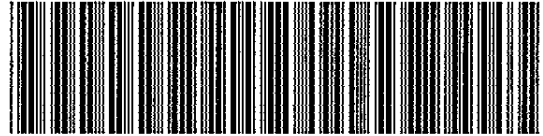

**ARTICLES OF DISSOLUTION
