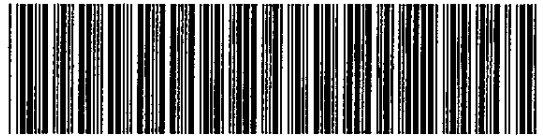



ARTICLES OF ORGANIZATION
OF
RAE'S ACADEMY OF TAE KWON DO, LLC

The undersigned hereby makes and subscribes to these Articles of Organization intending to form a Limited Liability Company under the provisions of the Florida Statutes.

1. **Name.** The name of the Limited Liability Company is RAE'S ACADEMY OF TAE KWON DO, LLC ("Company"). The Company may conduct business under that name and under any other name or names upon which the manager(s) may select with the approval of the member(s). If the Company conducts business under a name other than that set forth in these Articles of Organization, then the Company shall file a fictitious name registration, as required by law, as to each such other name.


2. **Purpose.** The Company is organized to engage in any business permitted under applicable law.

3. **Duration.** The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the occurrence of any of the events specified in Florida Statutes, Section 608.441, unless continued by the unanimous consent of the remaining Member(s).

4. **Mailing Address and Street Address.** The mailing address and street address of the principal office of the Company is: 3469 W. Boynton Beach Blvd., Suite 16, Boynton Beach, Florida 33436.

5. **Registered Agent and Office.** The name of the initial registered agent of the Company is Ginger R. Schneider. The street address of the initial registered agent of the Company is 3469 W. Boynton Beach Blvd., Suite 16, Boynton Beach, Florida 33436.

Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. 
8. **Management of the Company.** The Company shall be managed by the manager(s). The following persons will initially be the manager(s):
