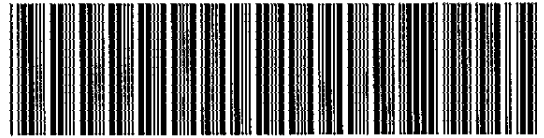

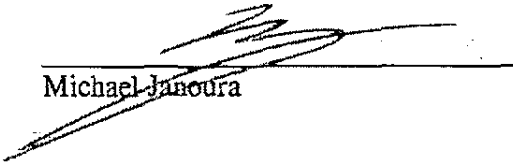
**ARTICLE VII - Operation**

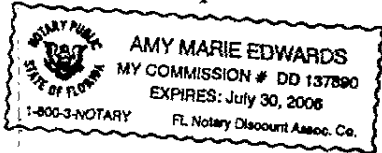
