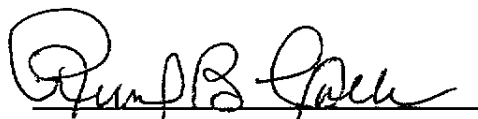

#### ARTICLE VI – PURPOSE

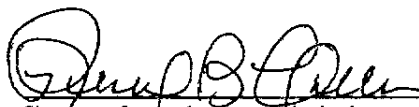
