ARTICLES OF ORGANIZATION

OF

R.P.B. INVESTMENT GROUP LLC

THE PROPERTY OF THE PARTY OF TH The undersigned, for the purpose of forming a limited liability company and the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be R.P.B. INVESTMENT GROUP LLC, ("Company").

ARTICLE 2 - ADDRESS
