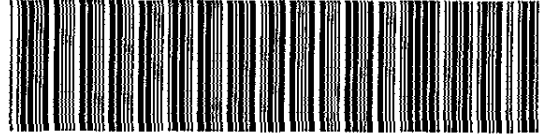

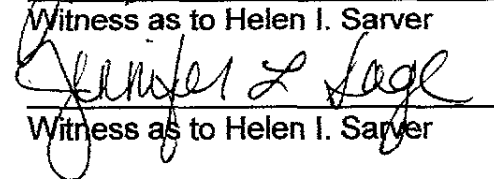
ARTICLE V
