

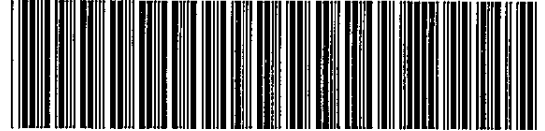

The name of the Limited Liability Company is LITTLE HAVANA – 1444 SW 5 ST, LLC (the "Company").




