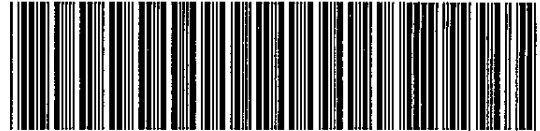

The name of the Limited Liability Company is LITTLE HAVANA – 520 SW 14 AV, LLC (the "Company").


