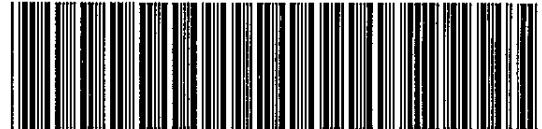

The name of the Limited Liability Company is LITTLE HAVANA – 2244 SW 9 ST, LLC (the "Company").


