ARTICLES OF ORGANIZATION

FOR

IRP 1203, LLC

THE UNDERSIGNED MEMBER hereby adopts the following Articles of Organization for the purpose of forming a limited liability company under the Florida Limited Liability Company Act.

ARTICLEI

Company Name and Principal Office

The name of the limited liability company shall be IRP 1203, LLC (referred to 1.1 herein as the "Company"), and the mailing and street address of the Company's principal office. shall be located at 4417 SW Long Bay Drive, Palm City, Florida 34990. - (b) Execute Documents Necessary to Exercise Authority. The Manager shall have full authority to make, endorse, accept, receive, sign, seal, execute, acknowledge and deliver any and all contracts, deeds, assignments, agreements, mortgages, security agreements. pledge agreements, certificates, hypothecations, affidavits, checks, notes, closing documents, bonds, vouchers, receipts and/or such other instruments in writing, of whatsoever kind and nature as may be necessary or proper with reference to the purchase, acquisition, lease, encumbrance, mortgage, sale or conveyance of Company property; and
- (c) Accent and Direct Proceeds. The Manager shall have full authority to accept or direct distribution of the any and all proceeds from such sale, lease, mortgage or conveyance of the designated Company property.
