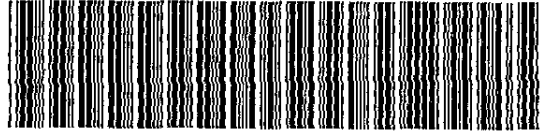



Article I. Name: The name of the Limited Liability Company is **J D LAND HOLDINGS, LLC**.




