



## ARTICLES OF ORGANIZATION

## Justinsane Customs, L.L.C.

(a Florida Limited Liability Company)

THE REPORT OF THE PARTY OF THE The undersigned certifies that I have organized for the purpose of becoming a Kin liability company under the laws of the State of Florida, providing for the formation, right privileges and immunities of limited liability companies.

(Name and Principal Place of Business)

(Membership Restrictions - Admissions)

Additional persons or entities may be admitted to the limited liability company as members

upon the unanimous consent of the current members and on such terms and conditions as determined by the members and in accordance with these Articles and the Operating Agreement of the limited liability company.

# ARTICLE V (Right to Continue Business)

On the death, withdrawal, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on the consent of a majority (or all) of the remaining members within ninety (90) days of the terminating or dissolving event.

# (Management)
