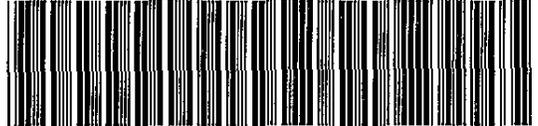

ARTICLE I  
Name

The name of the limited liability company is MERCCO USA, LLC (hereinafter called the "Company").

ARTICLE II  
Duration

The existence of the Company shall be perpetual.

ARTICLE III  
Principal Office

The mailing address and the street address of the principal office shall be c/o Mark Lawrence, Esq., 801 Brickell Ave., Suite 900, Miami, Florida 33131.

ARTICLE IV  
Initial Registered Office and Registered Agent

The street address of the Company's initial registered office in the State of Florida, Mark Lawrence, Esq., 801 Brickell Ave., Suite 900, Miami, Florida 33131, County of Miami-Dade, and the name of its initial registered agent at such office is Mark Lawrence .

ARTICLE V  
Restrictions on Membership and  
Right to Continue After Withdrawal of a Member

Members shall have the right to admit new members by the consent of the members owning 100% of the interests in the Company. Contributions required of new members shall be determined as of the time of admission to the Company. A member's interest in the Company may not be sold or otherwise transferred except with the consent of the members owning 100 % of the interests in the Company. Upon the occurrence of any event that terminates the continued membership of a member in the Company, the remaining members shall have the right to continue the business upon consent of the members owning a majority of the interests in the Company.

**ARTICLE VI**  
**Management**

The Company is to be managed by managers, who shall serve as managers until the first annual meeting of members or until their successors are elected and qualified. The Company's initial manager and his address is: Serkan Lacin, Manager, 3011 Greene Street, Hollywood, FL 33020

**ARTICLE VII**  
**Indemnification**

The Company shall indemnify and shall advance expenses on behalf of its members and managers to the fullest extent not prohibited by any law in existence either now or hereafter.
