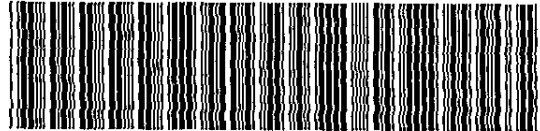

FIRST: The name and address of this corporation is **METAL FABRICATION LLC**, Document Number L06000040969, 911 Northwest 209th Avenue, Bay 125, Pembroke Pines, Florida 33029.

SECOND: The date of the adoption of these Articles of Dissolution is May 2, 2006.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421. The remaining property and assets have been distributed among its members in accordance with their respective rights and interests.
