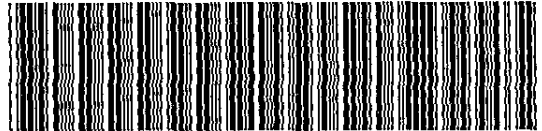

**ARTICLES OF ORGANIZATION  
OF

A FLORIDA LIMITED LIABILITY COMPANY**

**ARTICLE I  
NAME**

The name of this Limited Liability Company shall be SAI JAL, LLC, and its principal place of business shall be located at 3956 West Colonial Drive, Orlando, Florida 32808.

**ARTICLE II  
COMMENCEMENT OF EXISTENCE**

This Company shall exist for a period of thirty (30) years commencing on the date of filing of these Articles of Organization with the Florida Secretary of State, unless sooner dissolved according to law.

**ARTICLE III  
GENERAL PURPOSE; GENERAL POWERS**

The general purpose of this Company shall be the transaction of any and all lawful business. No Member shall be entitled to receive interest in its or his contributions to capital. Each Member's contribution to capital shall be in cash or property as agreed upon by the Members. Additional contributions to capital by the Members may be required pursuant to acts of the Board of Managers.

**ARTICLE V**  
**INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of this Company shall be located at 3956 West Colonial Drive, Orlando, Florida 32808, and the initial Registered Agent of this Company at that address shall be Vasantlal Patel. The Company reserves the right to amend or repeal any provisions contained in these Articles of Organization, or any amendment thereto, and any right conferred upon the Members is subject to this reservation.

**ARTICLE XI**  
**HEADINGS AND CAPTIONS**

The headings or captions of these various Articles of Organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various Articles shall not be influenced by any of said headings or captions.

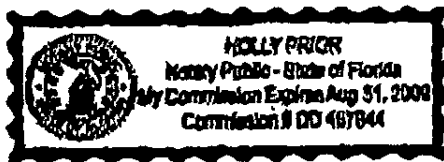
