OF

THIS IS TO CERTIFY THAT:

- FIRST:** This Article amends the Articles of Organization of SAI JAL, LLC, a Florida Limited Liability Company.
- SECOND:** The Articles of Organization were filed with the Florida Department of State on April 20, 2006, under Document Number L06000041324.
- THIRD:** Article IV of the Articles of Organization is hereby amended by deleting the existing Article IV and replacing it with the following:

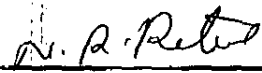
**"ARTICLE IV
CONTRIBUTIONS TO CAPITAL**
