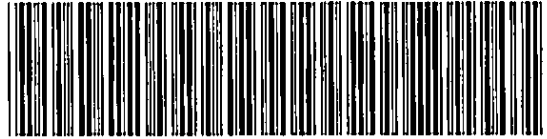

THIS IS TO CERTIFY THAT:

- FIRST:** This Article amends the Articles of Organization of SAI JAL, LLC, a Florida Limited Liability Company.
- SECOND:** The Articles of Organization were filed with the Florida Department of State on April 20, 2006.
- THIRD:** The Articles of Organization were amended by Articles of Amendment filed with the Florida Department of State on May 15, 2008,
- FOURTH:** Article IV of the Amended Articles of Organization is hereby amended by deleting the existing Article IV and replacing it with the following:

**"ARTICLE IV
CONTRIBUTIONS TO CAPITAL**

The initial capital of the Company shall be Five Hundred and No/100 Dollars (\$500.00), which shall be contributed by the members in accordance with their initial ownership interests in the Company, which are as follows:

<u>Member</u>	<u>Ownership Interest</u>
Navinchandra Patel	54%
Vasantlal Patel	18%
Bhaga Patel	18%
Virenkumar Patel	10%

No Member shall be entitled to receive interest in its or his contributions to capital. Each Member's contribution to capital shall be in cash or property as agreed upon by the Members. Additional contributions to capital by the Members may be required pursuant to acts of the Board of Managers."
