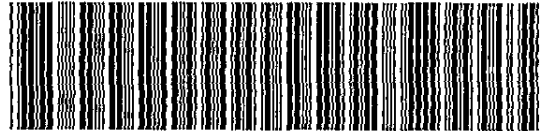



**ARTICLES OF ORGANIZATION  
OF  
JD'S LAWN & TRACTOR SERVICE, LLC**

Pursuant to the Provisions of the Florida statutes, the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

**ARTICLE I  
NAME**

The name of the limited liability company is **JD'S LAWN & TRACTOR SERVICE, LLC** (the "Company").

**ARTICLE II  
DURATION**

The Company shall have a duration from the date of organization until December 31, 2035, unless it is dissolved and its affairs wound up prior to that date in accordance with the Florida Limited Liability Company Act (the "Act").

**ARTICLE III  
PURPOSES**

The purpose for which the Company is formed is to engage in the business of landscaping, lawn care, lot cleaning and maintenance services, and to engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act. 


