ARTICLE I

Name

Transfer of Member's Interest

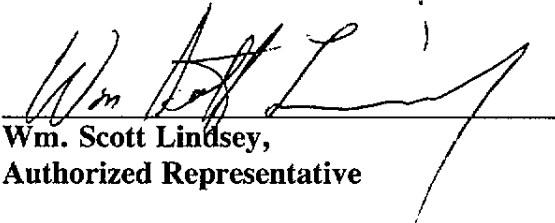

Name and Address of Registered Agent

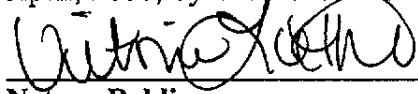

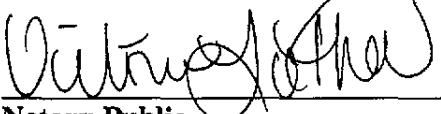
