#### ARTICLE VI. ALMISSION OF ADDITIONAL MEMBERS

Pursuant to Section 608.4232 of the Act, the Company may attnit additional members only upon the affirmative vote of a majority of the members of the Company in attendance at a duly called meeting of the members or by written consent of a majority of the members of the Company. Any new member which is approved by the members of the Company as set forth herein shall become a member of the Company upon payment of the contribution to the capital of the Company as established by the members, and upon such member's agreement to comply with those Articles of Organization, the Operating Agreement and such other documents, statutes, rules and regulations or guidelines as the members may from time to time determine in their sole discretion.

## ARTICLE VII. RIGHT OF ASSIGNEE TO BECOME A MEMBER

An assignee of 2 member's interest in the Company may become a member of the Company, and acquire the rights, powers and obligations and be subject to the restrictions and liabilities of a member of the Company, upon the affirmative vote of a majority of all of the members of the Company (excluding the member seeking to transfer his interest in the Company) which vote is taken at a duly called meeting of the members or by written consent of 2 majority of the members of the Company (excluding the member seeking to transfer his interest in the Company) as set forth in the Operating Agreement adopted by the Company, provided such assignment and admission of such assignment at a member compiles with the terms and conditions of the Operating Agreement adopted by the Company. If an assignee becomes a member of the Company, the assigner is not to be released from its liability or obligations to the Company.

#### ARTICLE VIII. DISSOLITION OF COMPANY

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the combined membership of a member in the Company, the Company shall be dissolved unless a majority of the other members elect to continue the Company either upon the affirmative vote of such other members, which vote is taken at a duly called menting of the members or by written consent of such other members of the Company.

# ARTICLE XI AMENDMENT TO ARTICLES OF ORGANIZATION


