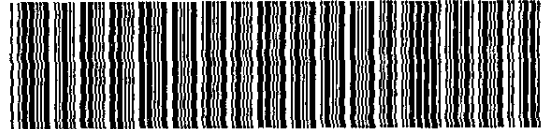

***ARTICLE I NAME***

The name of the limited liability company shall be Advanced Window Tinting, LLC ("Company").

***ARTICLE II- ADDRESS***
