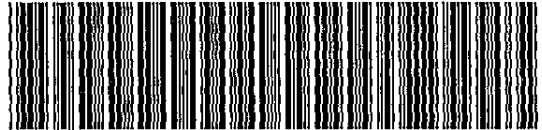

ARTICLES OF ORGANIZATION  
OF  
110%, LLC

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, hereby adopt the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is 110%, LLC.

ADDRESS

ARTICLE VI

MEMBERS' RIGHTS TO CONTINUE BUSINESS

The remaining member(s) of the limited liability company shall have the right to continue the business on the death, retirement, resignation, expulsion or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, provided each remaining member consents thereto in writing.

ARTICLE VII

INITIAL REGISTERED OFFICE AND AGENT


The street address of the initial registered office of the limited liability company is 1923 Rothbury Drive, Jacksonville, Florida 32221, and the name of the initial registered agent of the limited liability company at that address is Pete Wheeler. By executing these Articles as the organizing member and initial registered agent of the limited liability company, Pete Wheeler hereby accepts his appointment and agrees to act in this capacity and to comply with the provisions of all statutes relating to the proper and complete performance of his duties, and further states that he is familiar with and accepts the obligations of his position as registered agent.
