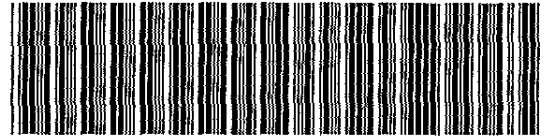

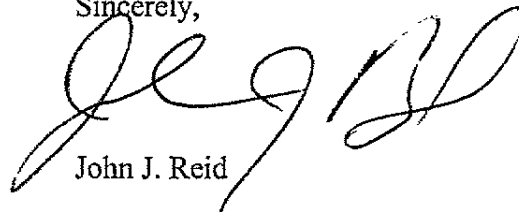

ARTICLES OF ORGANIZATION
of
NORTHWOOD DENTAL ASSOCIATES, PLLC
a Florida professional limited liability company

ARTICLE I
NAME

The name of this professional limited liability company is Northwood Dental Associates, PLLC (the "Company").

ARTICLE VIII NATURE OF BUSINESS

To conduct those lawful activities that are authorized by Chapter 621, Florida Statutes, as from time to time amended, and to exercise those powers, rights and procedures set forth in Chapter 608, Florida Statutes, in a manner not inconsistent with Chapter 621, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.

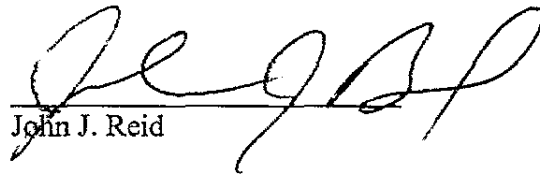
ARTICLE VIII MEMBERSHIP INTERESTS

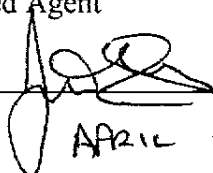
