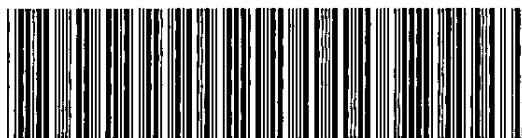

The Company is to be managed by the manger(s) of the Company. The manager of the Company is:

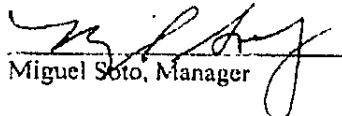

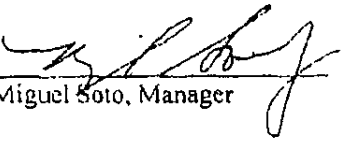
