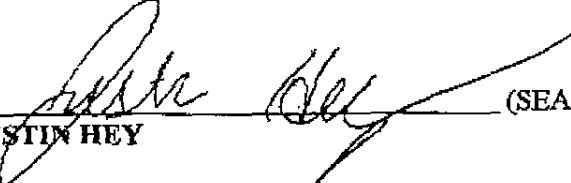
**ARTICLE VI:

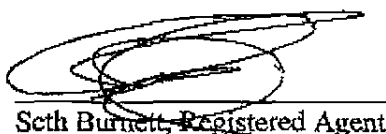

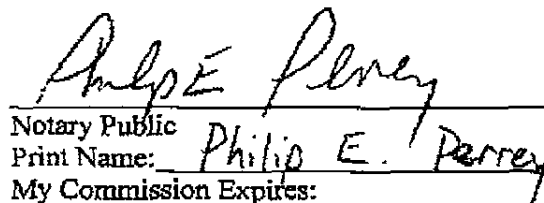
