ARTICLES OF ORGANIZATION

The undersigned organizer hereby forms a Limited Liability Company under Chapter 6080f the laws of the State of Florida.

#### ARTICLE I. NAME

The name of the Limited Liability Company ("Company") shall be Pro Clean of Southwest Florida, LLC.
