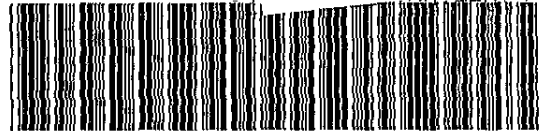

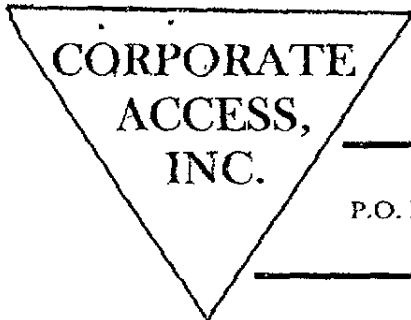

ARTICLE II - ADDRESS


