

**ARTICLES OF ORGANIZATION OF**  
**PASCAL PARTNERS, LLC**

**ARTICLE I**  
**NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this limited liability company shall be PASCAL PARTNERS, LLC and the mailing address and street address of its principal office shall be 12653 SW County Road 769, Lake Suzy, FL 34269, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

**ARTICLE II**


