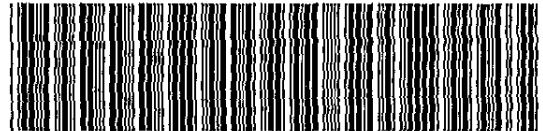

The period of duration for 1000 Broadway, LLC shall be perpetual.

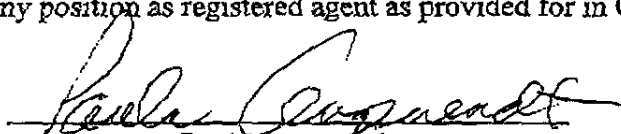
ARTICLE IV - Registered Agent:
