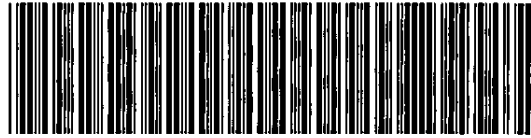

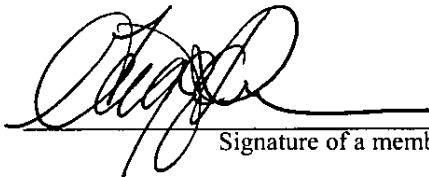

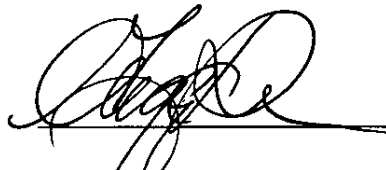
**ACTION BY CONSENT OF ORGANIZER
