ARTICLE 1: NAME

The name of the limited liability company shall be Seneca Moss, LLC (the "Company").

The Company may admit any additional members upon the member becoming a party to the operating agreement.

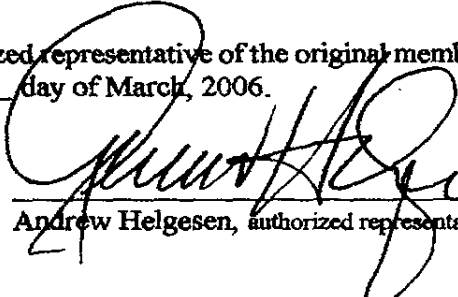
ARTICLE 10: AMENDMENT
