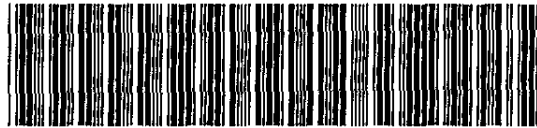



ARTICLE I - Name

The name of this limited liability company shall be Denson Properties, LLC.

ARTICLE II - Duration
