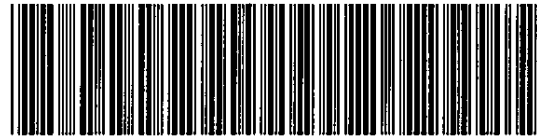



## **ARTICLE VIII - CONTINUATION**


