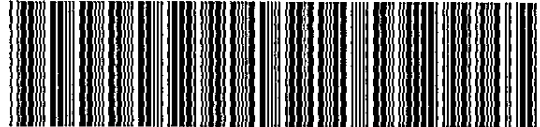

ARTICLES OF ORGANIZATION
OF
PALUMBO & LEVINS, LLC

The undersigned, for the purpose of forming a limited liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I-NAME

The name of the Limited Liability Company shall be **PALUMBO & LEVINS, LLC** ("Company").

ARTICLE II-ADDRESS

The mailing address and street address of the principal place of business of the Company shall be **6810 Porto Fino Circle, Fort Myers, Florida 33912**, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE III - DURATION

The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

ARTICLE V -- CAPITAL CONTRIBUTIONS

Each member shall make capital contributions to the company only on the unanimous consent of all the members, or as provided in the regulations.

ARTICLE VI-INITIAL MEMBERS

There shall be two (2) initial members of this limited liability company, whose names, and addresses and percentages of ownership are as follows:

ARTICLE VII – ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may not transfer his or her interest in the company except with unanimous written consent of all members, or except as specified in a separate written agreement regarding purchase and sale executed by all members. The transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE VIII – MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous vote of all the remaining members.

ARTICLE IX – DISTRIBUTIONS

The members shall be entitled to the net profits, as defined in the regulations, arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company. The distribution of the profits shall be determined as provided in the regulations of the company.

ARTICLE X – MANAGEMENT

The company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 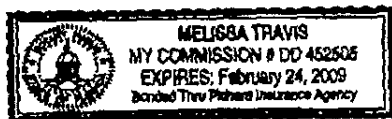

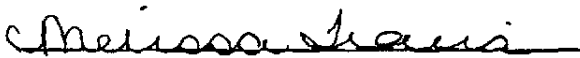
