**ARTICLES OF ORGANIZATION
FOR
BAY HILL, LLC**

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of BAY HILL, LLC ("Company"), under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I
NAME**

**ARTICLE II

The Company shall admit new members as provided in the Operating Agreement of the Company.


**ARTICLE VII
