ARTICLES OF ORGANIZATION FOR BAY HILL, LLC

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of BAY HILL, LLC ("Company"), under the Florida Limited Liability Company Act, Chapter 608, Fla Stat., adopts the following Articles of Organization:

ARTICLE I
