**ARTICLES OF ORGANIZATION
OF

**ARTICLE I
NAME**

The remaining members of the Company may continue its business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of

**ARTICLE VII
MANAGEMENT OF THE COMPANY**

The Company will be a manager managed company managed by its managers in accordance with and subject to the requirements of the Act and the Operating Agreement of the Company.
