Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is Alta Bluff Animal Hospital, LLC (the "Company").
2. The date of filing of the Articles of Organization of the Company was May 1, 2006.
3. That Article VII of the Articles of Organization of the Company is hereby amended and replaced in its entirety to read as follows:
