**ARTICLES OF ORGANIZATION****KAT 2 PROPERTIES, L.L.C.**

**ARTICLE I - NAME**

**ARTICLE VII - MEMBERS' RIGHT TO CONTINUE BUSINESS**

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or members, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous vote of all the remaining members.
