ARTICLES OF ORGANIZATION OF SANJAC ENTERPRISES, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the laws of the Florida Limited Liability Company Act, F.S. Chapter 608, hereby declare that the following Articles shall be the Charter and authority for the conduct of business of such limited hability company.

bankruptcy or dissolution of a mender, of the necurrence of any other event that terminates the continued membership of a member in the company, the remaining members shall have the right continue the business upon unanimous consont of such remaining members.

ARTICLE VII

Except as set forth in the Operating Agreement, the general nature of the husiness or husinesses to be transacted and which the company is sufficient to transact in addition to those authorized by the laws of the State of Florida, and the powers of the company, shall be as follows:

- 4. To enter into and make all recessary contracts for its business with any petson, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government or governmental authority, or of any political or administrative subdivision or department thereof, and to assign, cancel or rescind any of such contracts.
- 5. To exercise all or any of the company powers and to carry out all or any of the purposes enumerated herein, otherwise granted or permitted by law, while acting as agent, nominee, or attorney-in-fact, for any persons or corporations, and perform any service under contract or otherwise for any corporation, joint stock company, association, partnership, attorney-in-fact, syndicate, individual or other entity, and in such capacity or under such arrangement develop, improve, stabilize, strengthen, or extend the property and commercial interest thereof, and to aid, assist, or participate in any lawful enterprise in connection therewith or incidental to such, agency, representation, or service, or to render any other service or assistance insolar as it lawfully may under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.
- 6. To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers herein set forth, either alone or in association with others, incidental or pertaining to; or going out of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the State of Florida.
- 7. The several clauses contained in this statement of the general nature of the business or businesses to be transacted shall be construed as both purposes and powers of this company, and
