AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR PARK LAKE MAITLAND, LLC

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned (the "Member") being the sole Member of PARK LAKE MAITLAND, LLC, hereby executes and adopts the following Amended and Restated Articles of Organization pursuant to Chapter 608, Section 608.411, <u>Fig. Stat.</u> under the Florida Limited Liability Company Act which Amended and Restated Articles of Organization replace in their entirety the previously adopted Articles of Organization of Company filed with the Florida Secretary of State on May 3, 2006:

ARTICLE NAME

The name of the limited liability company is:

ARTICLE II INITIAL REGISTERED AGENT, REGISTERED OFFICE ADDRESS

ARTICLE III DURATION

The Company's existence shall commence upon the acceptance of these Articles of Organization by the Secretary of State, and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

The Company shall be managed by the Member of the Company as provided in the Company's Operating Agreement.
