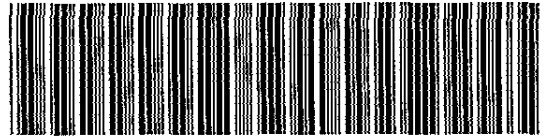

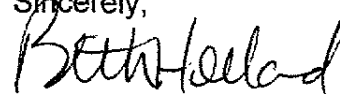

ARTICLE I

The name of this Limited Liability Company (the "Company") is CONDO RESOURCES, LLC and its mailing address is 55 E. Pine Street, Orlando, FL 32801, and the principal place of business of the Company shall be located at 55 E. Pine Street, Orlando, FL 32801.

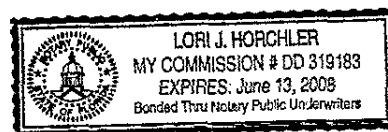
