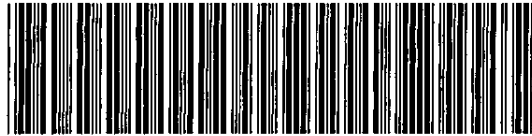




**Articles of Dissolution

Clifton Turf, LLC**


In accordance with Section 608.445 of the Florida Limited Liability Company Act, the undersigned executes these articles of dissolution and states the following:
